NOTICE OF HAVING MADE A VARIATION OF CORK COUNTY DEVELOPMENT PLAN 2014

Variation No. 2

Notice is hereby given, pursuant to Section 13(8) of the Planning & Development Act, 2000 (as amended), that Cork County Council at a meeting held on 27th January, 2020, has, in pursuance of the provisions of the above Act, made a Variation of the Cork County Development Plan 2014.

The purpose of the variation is to;

“Amend Paragraph 7.10.5 Retail Outlet Centres (previously amended as part of Variation No. 1 of the County Development Plan 2014) to provide strategic planning policy support for the provision of a Retail Outlet Centre in the N25 Corridor sub catchment of the County Metropolitan Strategic Planning Area and include new paragraph 7.10.6 ‘Innovation in the County’s Retail Offer’.

The Variation of the County Development Plan consists of 2 Volumes set out as follows:-

- Volume 1: Adopted Variation which is available on hard-copy or on-line.
- Volume 2: Environmental Reports (which includes the SEA Screening Report including Strategic Flood Risk Assessment and the Natura Impact Screening Report) – which is only available on-line at www.corkcocodevplan.com
